In 0.7 miles The Waterfall will be on the right



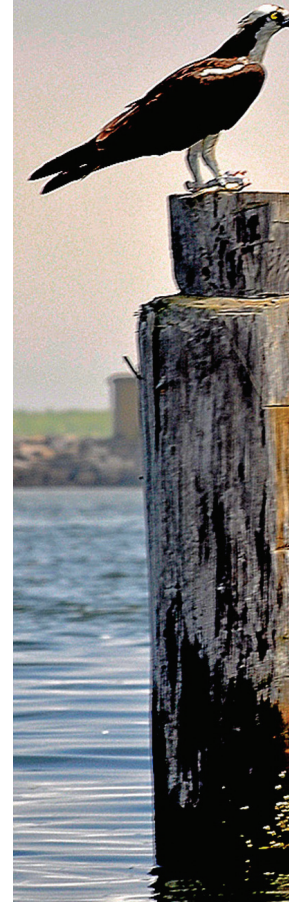
