

Official Sweepstakes Rules

No purchase necessary to enter or win. A purchase or payment will not improve your chances of winning.

Eligibility: This Wilmington Earth and Arbor Day Sweepstakes (“Sweepstakes”) is open to all residents of Wilmington, Delaware. Individuals under the age of 18 may only enter with parent or guardian consent. Void in all other areas outside Wilmington, Delaware. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law.

Sponsorship: This Sweepstakes is sponsored by the City of Wilmington, Delaware (“Sponsor”). This Sweepstakes is administered by the Partnership for the Delaware Estuary (“Administrator”). Sponsor, Administrator, its affiliates, or any entity involved in the development, production, implementation, administration, or fulfillment of the Sweepstakes, including without limitation, the immediate family members of such individuals are not eligible to participate.

Entry period: This Sweepstakes begins on April 19, 2021 at 10:00 am EST and ends on April 25, 2021 at 10:00 am EST (“Entry Period”).

How to Enter: During the Entry Period, participate in our try-it prompt according to the daily theme and then visit the Sweepstakes registration page, located at <https://www.delawareestuary.org/earthandarbort/> and follow the instructions to electronically complete and submit the Sweepstakes entry form. You will be asked to provide basic contact information, including your name and email address. You will be asked to provide documentation of completing the try-it activity if available. However, this is not required to enter.

Limitations on Entries: Limit one entry per category per person. Categories include: Plant Powered Monday, Transportation Tuesday, Watershed Wednesday, Earth Day, and Tree Friday. No third party entry or entry through any sweepstakes service is permitted.

Prizes: Five (5) prizes will be awarded, each valued at approximately \$100. One winner will be selected for each day’s prize. Individual must enter for a particular day to be included in the drawing. Winner is solely responsible for any federal, state, and local taxes.

Drawing: Winners will be selected in a random drawing among all eligible entries collected during the Entry Period, taking place on or about April 26, 2021. The drawing will be conducted by the Administrator, whose decisions and interpretations on all matters relating to the Sweepstakes and these Official Rules are final and binding in all respects. Administrator reserves the right to disqualify any entrant or winner and may refuse to award a prize to a person who is not eligible or has violated a rule, gained unfair advantage in the Sweepstakes, or obtained winner status using fraudulent means. Winner will be notified by email. Inability of Administrator to contact winner by email within one week after selection may result in disqualification of winner and an alternate winner may be selected in a random drawing at Administrator’s discretion. Prize will be sent to winner by US mail, email or individual delivery, within thirty days after winner has been notified and accepted the prize. If prize is returned as undeliverable, then the prize will be forfeited and another winner will be randomly drawn.

Odds: The odds of winning will depend on the number of eligible entries received, according to the eligibility requirements in the Sweepstakes.
